Canvassing Board to meet following the Logic and Accuracy Testing to review potentially invalid ballots and consider authorizing the duplication of certain Vote-by-Mail ballots (if needed), and authorizing the tabulation of Vote-by-Mail ballots.
Tuesday, 06/18/2019 6:00 p.m.	Canvassing Board to meet to continue canvassing, including duplication of ballots, canvassing potentially invalid ballots.
Tuesday, 06/18/2019 7:00 p.m. or later	Release of preliminary results.
Friday, 06/21/19 10:00 a.m.	Conclusion of Provisional Ballot Review. Announce Official Results . Canvassing Board to announce time of a recount, if ordered.
Monday, 06/24/19	Post-Election Voting System Manual Audit for the Municipal Special Election or Canvassing Board to convene for recount, if needed.
